

*COVID-19:* **risk assessment considerations  
for mobile workers  
(electronic, fire and security companies)**

## 1. Introduction

This guidance has been put together in an effort to assist electronic fire & security companies during the coronavirus (COVID-19) outbreak in the UK in managing the risk of those mobile workers who have to travel to different sites to carry out their work. This guidance should be used in conjunction with the Government advice on staying 'COVID Secure' in the workplace. The guidance assumes that a risk assessment has already been carried out as regards whether or not the service that is being provided is necessary, i.e. can it be done remotely?

The considerations outlined in this document are additional considerations over and above what would normally be required of your existing processes/procedures.


### 3. The mobile worker



The mobile worker (the worker carrying out the necessary services on customers sites for example a mobile worker despatched to site for maintenance and/or repair) should:

- 3.1. **Not** be used as mobile worker during the coronavirus outbreak if they are in vulnerable groups, as this will increase their risk of contracting the virus.
- 3.2. **Not** be suffering any symptoms (no matter how mild), if they do, they should be sent home immediately.
- 3.3. **Not** work when it is unsafe to do so, i.e. where either a safe working environment or safe system of work cannot be provided.
- 3.4. Follow hygiene advice produced by the government (or UK regional requirements), e.g. washing of hands etc. and if needed use of sanitising gel or sanitising wipes for hands and other surfaces where required.
- 3.5. Use appropriate PPE when required by your organisation and take reasonable care of it. For example, the use of face masks, protective gloves etc.
- 3.6. Be aware of the correct use and/or be trained in:
  - the safe use, storage and maintenance of any additional PPE measures they are expected to use, including what to do if it gets damaged or is faulty.
  - social distancing and what it means in terms of their actual role.
  - what to do if they show symptoms of coronavirus, i.e. stop work and go home.
  - how to report dangerous occurrences and near missus (as it relates to COVID-19), this could be excluding sites that cannot be made safe working environments in case further visits are requested). Any sites that are excluded should not be attended unless changes have been made to create a safe working environment for the mobile worker.
  - what constitutes a COVID-19 Secure working environment and mobile workers should be empowered to make that call when visiting a site.
  - appropriate hygiene measures, e.g. washing of hands etc. and if needed use of sanitising wipes for hands and other surfaces where required.

*Note: any training provided should be verified by the employer to confirm correct understanding of the requirements and recorded.*
